## How the Coalition Began

In 1985, the Michigan Association for Deaf and Hard of Hearing (MADHH, formerly MADHS) hosted a meeting for professionals and leaders working in the Deaf community. The meeting was organized to develop a unified voice representing the needs of Michigan's Deaf constituency. Together, this core group of professionals identified and prioritized issues facing people with hearing loss. With needs identified, MADHH then called a meeting of all agencies and organizations chartered to serve Michigan's Deaf citizens. Thirteen organizations and agencies joined together to form the Michigan Coalition for the Deaf.

In 1991, the Coalition changed its name to include the hard of hearing population in advocacy initiatives, becoming the Michigan Coalition for Deaf and Hard of Hearing People.

Today the Coalition is comprised of more than 40 agencies and organizations, committed to advocating for and with people with hearing loss throughout Michigan.

## How the Coalition is Supported

The work of the Coalition is carried out through the volunteer efforts and annual dues of members, and through administrative funding and support from Michigan Association for Deaf and Hard of Hearing. MADHH is a statewide collaborative agency that relies on financial support from service clubs, grants, local United Way agencies and donations.

### PURPOSE

To provide an effective statewide mechanism in which access and services for deaf and hard of hearing people can be enhanced through advocacy, program and resource development.

## How the Coalition Serves

The Coalition actively pursues systems change to better the lives of Michigan's deaf and hard of hearing citizens. We are proud of the successes achieved through our collaboration:

- Newborn screening for hearing loss in all Michigan hospitals and follow-up
- Amendment of Michigan's Interpreter law
- Restoration of Medicaid funding for adult hearing aids during Michigan's budget crisis.
- Advocacy for improved access to substance abuse and mental health treatment for deaf and hard of hearing people
- Community Emergency Preparedness Information Network (CEPIN) Training for emergency responders and people with hearing loss
- Accessible telecommunication: Michigan Relay Center, CapTel, and emergency alerting systems
- Educational choice and access, and the right of parents and students to select the appropriate educational options
