Topics will include the role of the Interpreter and the Counselor in the session; current clinical diagnoses that counselors and Interpreters face; how to communicate imperative clinical information to match the client's cognitive functioning; the importance of maintaining boundaries; the role of the therapist who counsels Deaf clients; how to recognize and avoid learned helplessness and how to help those in the environment understand that enabling can impact recovery.

Presenters

Melissa Watson, M.A. became Director of Clinical Programs at the National Deaf Academy in February, 2001. She directs and supervises treatment programs for Deaf children, adolescents and adults. Melissa worked at the National Mental Health Institute on Deafness upon completing her internship there. She worked at St. Vincent's Children's Center and Parkside Behavioral Health providing counseling at Columbus Colony Elder Care. She received her B.A. from Bloomsburg University in social work and her Master's Degree in Mental Health Counseling from Gallaudet University. Due to the number of residents with Autism and Mental Retardation, Melissa achieved her second Master's Degree in Applied Behavior Analysis at the Florida Institute of Technology.

Kelly Matamoros, CI/CT has been a professional Interpreter for over 9 years. In her early work as an Interpreter in the education system she noted the linguistic diversity among students and the lack of ASL exposure. She attended Gallaudet University to learn best practices and graduated with a Master's Degree in Deaf Education and continued to work as an Interpreter. Pursuing two professional tracks has served her well at NDA. Kelly started working at NDA in 2002 and took an active interest in Mental Health Interpreting. She became a full time staff Interpreter in 2004; promoted to Interpreter Coordinator in 2006. She oversees the Interpreting department, schedules Interpreters for clinical, administrative, medical and educational sessions on site, interacts with the multidisciplinary team to address communication needs and enhance services and mentors staff Interpreters as needed.
